

Real Estate Sale and Purchase

BGRS' real estate services include a comprehensive support package for families in both the departure and destination locations. We offer a full array of choices for selling a home under the four allowable pricing and policy options.

Homesale Services

- Appraised and Amended value program

- Buyer Value Option (BVO)
- Special Handling transactions

Property Management

In addition, for transferring families who do not wish to sell their homes, BGRS offers property management services including:

- Leasing and tenant finding/qualification process
- Property and tenant inspection audits
- Maintenance and repair management
- Financial management and reporting

These services are provided through local leasing firms that meet BGRS prequalification, training and security requirements.

Comprehensive Move Support

Homesale and property management are core services within BGRS' relocation package. Included in these services at no additional cost to the Agency are:

- **Marketing assistance** to maximize the potential sale and value of the transferee's home
- **Home finding assistance** support in the new location for buyers and renters, including scheduling and ensuring efficient and productive home finding trips
- **Temporary housing** assistance worldwide with multiple options from traditional hotels/motels to Airbnb's

- **Training** administrative personnel on the GSA Schedule program in agency relocation, finance, and procurement features BGRS business processes, technology tools and reporting capabilities.

Move Management Services

- In conjunction with, or independent of entitlement counseling, agencies may contract for expense management services that include preparation and management of travel authorizations, voucher preparation assistance, voucher review and payment, W-2 production, tax reporting and deposits.

Destination Rental Assistance

- In addition to our destination services for buyers, BGRS offers two programs to support families who elect to rent long or short term in the new location. Our two options include a self-guided tool kit with support by an assigned Relocation Consultant or a full-service support program.

Closing Assistance

- Closing assistance provides an opportunity for agencies to instruct BGRS to manage the closing process for an employee's home in the departure location only when the employee cannot be present, or when the employee is otherwise ineligible for the home sale option. Expenses are reimbursed to employees in accordance with the FTR and agency-specific policy.
